## STUDY VISA FOR GERMANY

#### **BASIC INFORMATION**

- 1. Use the following checklist to make sure your application and documents are complete. All documents listed here are to be submitted in the requested **form and order**.
- 2. You must submit your visa application for a study visa in the visa application center of our external service provider **TLScontact**. You need to book an appointment on the <u>TLS internet</u> page.
- 3. Documents, which are not in German or English language, must be submitted with a <u>certified German translation</u>. Alternativ: <u>USA</u> or <u>UK</u>.
- 4. **High school diplomas, university diplomas, etc. have to be presented in original with legalization.** Your original documents will be returned to you once your application has been processed. You must <u>legalize</u> your university degrees and diplomas **before** you submit your documents!
- 5. As a rule, the relevant immigration authority in Germany must approve visa applications. The visa can only be issued when this approval has been received.
- 6. That's why the processing time is about 4 5 weeks but can take longer in individual cases.
- 7. The German Embassy reserves the right to request further documents.
- 8. Please do not contact the German Embassy to check the status of your application during the normal processing period. Such inquiries are extremely time-consuming for the visa section and can thus not be answered.

## GENERAL INFORMATION

Foreign students who have been accepted by a German or a preparatory college (Studienkolleg) can apply for a visa to study in Germany. You are advised to secure your admittance or acceptance from the university as early as possible.

- During your studies, you can take up student jobs to help cover your expenses.
- Upon completing your studies, you will have the opportunity to look for a job.

## BASIC REQIRED DOCUMENTS

- 1. documents must be submitted in the original! The original will be returned to you after verification
- **2. one photocopy of the documents** is also required.

The photocopy must be copied on one side, must not be stapled / glued or tacked!

### **GENERALLY APPLIES**

If as a student you want to take out statutory health insurance, you must bear in mind that this insurance can only begin when you take up residence in Germany and after enrolment at the university.

If you **enter Germany beforehand**, private health insurance is required for the period between entry into Germany and enrolment and registering for statutory health insurance.

In its terms and conditions, travel health insurance can exclude protection if a long-term or permanent stay is planned. So-called incoming travel insurance can also contain such exclusions.

#### 4. PROOF OF ADEQUATE FINANCIAL MEANS

#### **FINANCING**

To stay in Germany the applicant must have at their disposal at **least 992 Euro per month**. Financial funds have to be proven for at least **one year that is at least 11.904 Euro** (for example, in the form of a blocked bank account or a formal undertaking by a third person to cover all costs).

In the case of financing in the form of a <u>blocked bank</u> account: Open the blocked account in good time BEFORE you apply for a visa.

When applying for a visa, only the official confirmation of the opening of the account including information on the amount paid in and the amount available per month will be accepted. A confirmation, which does not include this information, is not sufficient.

The visa fee is **75,00 Euro** and must be paid in local currency.

The fee is not refundable in case of rejection or withdrawal of the application.
